

INFORMATION PURSUANT TO ART. 13, GDPR 679/2016

Italian Multiple Sclerosis Foundation - FISM Onlus with offices at no. 40 Via Operai, Genoa, as Data Controller (hereinafter, "**Data Controller**"), pursuant to art. 13 EU Regulation n. 2016/679 (hereinafter, "**GDPR**"), provides the following information regarding the processing of personal data.

1. Purpose and subject of treatment

FISM guarantees that it will process personal data in a lawful and correct manner, it will gather and record them for defined, explicit and lawful purposes and will use them in line with such purposes. FISM shall make sure that such data are correct, updated, relevant, complete and not in excess for the purposes for which they have been gathered and processed.

Personal data - such as name, surname, telephone number, e-mail etc. - will be processed by FISM for the following purposes:

- scientific and administrative management of research project/ fellowship;
- obligations provided for by laws, regulations, community legislation or orders of authorities.

The legal bases of treatment can be identified, alternatively:

- in the execution of obligations coming from a contract pursuant to art. 6.1, lett. b) GDPR;
- in the fulfillment of obligations required by law pursuant to art. 6.1, lett. c) GDPR.

2. Method of treatment

The following treatments might be performed on personal data: collection, registration, organization, structuring, storage, adaptation or modification, extraction, consultation, use, comparison or interconnection, limitation, cancellation or destruction. The data may be processed by FISM electronically or in paper form suitable for guaranteeing security and confidentiality.

3. Storage time

The personal data will be stored for the period necessary with regard to the purposes indicated in this statement and in any case for a period of time not more than 10 years starting from the application.

4. Data Communication

Within the limits relevant to the processing purposes indicated above, data might be transmitted to suppliers (e.g. insurance companies, work consultancy studies, etc.) that perform activities on behalf of FISM, in their quality of data processor. Without the need for express consent (pursuant to Article 6 letter b) and c) GDPR), Data Controller may communicate data to judicial authorities as well as to those public and private entities, to whom communication is mandatory by law or for the fulfillment of the aforementioned purposes. data will never be disseminated or disclosed to unauthorized third parties.

5. Data transfer

Personal data will be stored on servers located within the European Union. Data will not be transferred to non-EU countries or in any case not subject to the GDPR regulations.

6. Nature of the provision of data and consequences of the refusal

The provision of data is mandatory and, therefore, any refusal to supply them in whole or in part can give rise to the impossibility for FISM to evaluate the application for research project / fellowship.

7. Rights of data subject

Data subject could exercise at any time the rights referred to in articles. 15-22 of the GDPR.

In this regard, Data Subject have the right to:

- request the updating, rectification, integration, cancellation, transformation into anonymous form, blocking of data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected;
- have information about the logic, the methods and the purposes of the processing;
- receive data in a structured format, commonly used and readable by automatic device;
- revoke any consent given in relation to the processing of your data at any time and object in whole or in part to the use of documents ;
- propose a complaint to the Authority, as well as to exercise the other rights recognized by the current legislation.

8. Method of exercising rights
